Foreword

It is my privilege to present the Report for By Elections held in November 2021 pursuant to Section 148 (2)(3) of the Electoral Act 2019 following the declaration of the seven (7) Parliamentary seats vacant by the Honorable Speaker dated 12th October 2021. As a result of election petitions, Court ruled to disqualify candidates from 4 electoral constituencies namely Sagaga 2, Aana Alofi 2, Falealili 2, and Aleipata Itupa i Lalo. Candidates from Sagaga 4, Safata 2 and Falealupo resigned from their seats following settlement of matter outside of court.

Prior to the By-Election 2021, The Electoral Act 2019 again, went under the microscope and saw several changes through the Electoral Amendments Act 2021 which was passed in September 2021. These changes made adjustments to planning and preparations towards polling day.

Once again, the Office of the Electoral Commission (OEC) with the support and assistance of the stakeholders, executed the processes outlined in the By Election Calendar commencing with voter registration, candidate nomination, confirming of polling booths, recruitment and training of polling officials,

A total of 22 candidates registered during the candidate nomination period. One candidate was disqualified following the court ruling on a candidacy challenge and one withdrew his candidacy as the close of the withdrawal of nomination. This result to six electoral constituencies returned to poll and twenty (20) candidates.

A comparative analysis of the participation of voters within the 6 Electoral Constituencies in By-Election and General Elections is shown with the aid of graphs and tables.

There were 46 Polling Booths and 10 Special Booths allocated for Polling Day and 21 Polling Booths allocated for Pre-Polling Day. Pre-polling was held on Wednesday 24th November to cater for the 1,011 voters who were eligible to pre-poll from the six (6) Constituencies.

The reduce in the number of issues raised during the polling process and the prompt response by our AEO IT officials in the relaying of the preliminary results was evidence of the improvement of our Vote Caster system following the review of issues that were encountered during general election.

We congratulate all the voters who made their votes count by participating in the by election process.



We extend our gratitude to the assistance provided by our stakeholders within the government, civil society, donor partners, volunteers and all the Officials who stood with us along the way to ensure that our voters are given a fair opportunity to cast their votes on Polling Day. Without your support, we would not have been able to accomplish our goals.

Last but not least, with much appreciation we wish to acknowledge the leadership of the Former Electoral Commissioner – Faimalomatumua Mathew Lemisio. Milestones were achieved in every aspect despite the challenges encountered in our journey as a team up to this very by-election process. Great leaders always make a difference. The Office of the Electoral Commission wishes you all the best in your future endeavors

3. PRE-ELECTION ACTIVITIES



3.1 LEGISLATION AMENDMENTS

Prior to the By-elections in November 2021, the Electoral Act 2019 ("the Act") was again went under the microscope in reconciling the issues raised and passed judgment on during the Candidacy Challenges after the General Elections. These issues were later inserted into the Act through the Electoral Amendments Act 2021 ("Amendment Act") passed in September 2021, which includes:

i) In Section 8(1)(c) **REGISTRATION OF MATAI TITLE AND RELIGIOUS MONOTAGA:** the registration of a matai title of a person intending to run for an election was amended to provide an avenue for potential candidates who have served his or her village/constituency after his or her matai title was conferred BUT have not registered his or her title. Therefore this opens the requirement of a registered matai title to having it registered before the lodgment day instead of the 3 consecutive years before lodgment day. Subsequently, a new subsection (1 (d) was inserted as a replacement to open the monotaga performed to any 3 consecutive years before the lodgment day to the registered matai title under subsection (1)(c).

Further amendments was made to the definition of monotaga under subsection (5) where the religious activities was revived therefore subsequent insertions were made to subsection (2)b)(iii) was inserted to reflect a person appointed by the Commissioner to confirm a religious activities monotaga, and a new subsection (8) was also inserted to provide conditions applied to the person appointed to confirm a religious monotaga.

ii) **WITHDRAWAL OF NOMINATION:** Other amendments made to section 53 where a new subsection (5) was inserted to bar a Candidate whom by motion challenged a decision made by the Commissioner when approving the nomination of another Candidate from his or her Constituency. The bar requires the Candidate who lodged the motion from withdrawing his or her Candidacy if he or she wins his or her motion, unless he or she is in a critical health condition.

iii) ALLOW OF SPECIAL BOOTHS: The revival of special booths was also included in the Amendment Act where section 54(2) was amended to include special booths of a Constituency outside of its Constituency.

iv) **PRE-POLLING DAY:** Section 60 was amended to specify that the period for pre-polling can be a day or more within a designated period allocated by the Commissioner.

v) **COUNTING OF PRE-POLLING VOTES:** Other amendments changed the process for the counting of prepolling votes casted where section 61(7) was amended to, at the end of pre-polling date instead of the counting of votes; the ballot papers used is tally until the Official Counting. This is to protect the secrecy of votes of each voter who were eligible to vote during the pre-polling, as experienced during the General Election. Furthermore, the list of voters qualified to pre-poll in the General Election remains for a by election arising as a result of an election declared void under sections 116 or 117 this was reflected in the insertion of a new subsection (11).

3.2 WARRANT



Following the Vacancies in Parliament, a warrant from the Speaker of Parliament to issue the Writ for By-Elections was received on Tuesday 12th October 2021 to supply vacancies for the Electoral Constituencies of Sagaga 2, Sagaga 4, Aana Alofi 2, Safata 2, Falealili 2, Aleipata Itupa i Lalo and Falealupo.

The vacancies for the four (4) Electoral Constituencies Sagaga 2, Aana Alofi 2, Falealili 2 and Aleipata Itupa i Lalo have arisen from the decision of the Supreme Court whereas the vacancies for the three (3) Electoral Constituencies of Sagaga 4, Safata 2 and Falealupo were due to the resignation of the Elected Members of Parliament. (Refer Annex 2)

3.3 WRIT OF BY-ELECTION

Following the Warrant from the Speaker of Parliament, the Commissioner then issued the Writ for By-Elections by way of Public Notice on Friday 29th October, 2021. Accordingly, Polling Day was declared for Friday 26th November 2021. (Refer Annex 3)

3.4 MEDIA AND PUBLIC AWARENESS

After discussions with the former Electoral Commissioner, it was then decided that there wasn't a need to re-engage ourselves to a major awareness campaign drive as we had done with the recent general election in April. That awareness program was thoroughly done utilizing every media outlets in the country. But then we opted to conduct only LIVE reports from within our own premises using our own resources and personnel, not only to meet time but also saving costs.

Most of our awareness program for the six by-elections was done through public notices, aired on local radio and TV, and posted on the official office website.

One LIVE interview was done in the main office with the former Commissioner Faimalomatumua M Lemisio and the ACEO for the Electoral Roll Lefau Francis Ainu'u, prior to the relocation of staff to the Tuanaimato Headquarter and the execution of the by-election. At least 10 LIVE updates were done through the voting dates, and also when the results were posted as well as the recounts on the following dates.

All of these reports were posted on social media and the official website of OEC for public information.

3.5 REGISTRATION ACTIVITIES



By the decision of the court after Election petitions, seven electoral constituencies were eligible for by-election to choose their representatives. Out of the seven (7) electoral constituencies, three (3) of which namely Falealupo, Sagaga 4 and Safata 2 fell under the ambit of **Section 141(2)(a) of the** *Electoral Act 2019*.

Hence the above-mentioned Electoral Constituencies were not barred from using the same Electoral Rolls as the ones used in the General Elections which was the case for the other four (4) Electoral Constituencies subject to **Section 150(1)** of the *Electoral Act* respectively.

When the writ was received, plans for special registration work for Sagaga 4, Safata 2 and Falealupo were already in placed pending execution. The registration team was sorted into four teams, three to cater for all three constituencies with active Rolls and one at the main office at Mulinuu. A special public notice was issued on various media outlets to inform the public of the registration schedule as well as the designated venues for the program.

All registration services were made available for the interested public during these special registration programs. This include first time registrations, voters who wished to transfer (provided that they satisfy all requirement), voters who wanted to amend their personal information on the Roll as well as immediate family members to verify their deceased relative to be removed from the Electoral Roll.

Data above shows that Safata 2 had the highest number of New Registration added on the Roll since it was closed temporarily for the last 2021 General Election. Similarly to data recorded in the last General Election registration, majority of new voter registration opted to register at their residential electoral constituency. As shown on the numbers above, one voter from the Sagaga 4 Electoral Constituency who chose to register on the Electoral roll using his registered Matai title. Voters within the 21-30 years age group has been recorded as the highest number of new registration in this brief time that these three rolls were opened. Scattered numbers from the other age groups as noted above, and one voter within the age group of 71-80 had finally registered as a voter for this by-election. This goes to show that there are qualified voters out there who have not yet registered as voters on the Electoral Roll.

3.7 VOTER TRANSFER IN

Electoral Act 2019: Section 18. Eligibility to transfer: (1) Subject to sections 15 and 156 a voter is eligible to transfer registration from one constituency to another if the transfer is after 10 years:

(a) from the date of the first registration as a voter; or

(b) from the date of the most recent transfer or re-registration.

(3) A candidate or person who qualifies under section 16(1)(b) or 16(1)(c) is exempt from the period under subsections (1) and (2), provided that persons exempted under section 16(1)(b) or 16(1)(c) transfer within seven (7) days from the date a candidate's nomination is made under section 47.



The Sagaga 4, Safata 2 and Falealupo Roll were also open for Transfer applications from any Electoral Roll, except from Sagaga 2, Aana Alofi 2, Falealili 2 and Aleipata Itupa I Lalo (other constituency with pending by-election). Qualification for Transfer is similar to that of New Registration. The only exception to this rule is the immediate family members of the registered candidate, which includes the legal spouse and children. Once the candidate is registered and approved as a candidate for election, his legal spouse and children (if they are registered on a different electoral roll) can transfer to the electoral constituency that the candidate is competing from within 7 days after candidacy nomination. A total number of 52 approved transfer applications recorded for this by-election.

3.8 REVIEW OF THE ELECTORAL ROLLS



All three Electoral Rolls were thoroughly reviewed before printing for by-election.

VERIFIED DECEASED REMOVED ELECTORAL ACT 2019:

Section 24. **Removal of names from roll**: (1) The Commissioner must, at any time except as provided in subsection (3), remove from a roll:

(b) the name of a person of whose identity the Commissioner is satisfied and whose death has been notified

(ii) in writing by the spouse, father, mother, brother, sister or child of the deceased provided that the person so advising the Commissioner is at least 18 years of age;

In the process of reviewing the three Electoral Rolls that were opened for registrations, four names were removed from their respective electoral rolls in that they had satisfied the requirement of verification for removal as stipulated by the Electoral Act 2019. Regardless of the high number of deceased voters identified during this special program, the only names that could be removed were the ones confirmed by immediate family members.

Note that all Electoral Rolls were opened for amendment and correction of names and voter's personal information on the Roll, provided that they present the required verifying documents.



4. ELECTION PERIOD ACTIVITIES




4.1 ICT IN BY-ELECTION

4.1.1 VoteCaster

The Votecaster system was used to enabled live verification and search function of voters participated in all by election polling stations on pre-polling and polling day.

The Votecaster system utilized a 2-way authentication with OTP (One Time Pass) and Static IP SIM cards. The configuration enabled monitoring of the system and implemented security controls from the Operation Center. A manual form process was also in place to verify Votecaster information on voter's participation. The dual process has a 100 percent success rate.



4.1.2 Equipment

A total of 84 tablets were used to run the Votecaster System in all polling stations during by-election. Tablets used static IP SIM cards and verification codes (OTP) couple with usernames and passwords to access the votecaster system.

10 Laptops were use at the Operation Center Call Center to address any issue encountered with voters at polling booths. 18 laptops were configured as backup to tablets for low Cell coverage areas such as Falealili 2 and Aleipata Itupa Lalo. These laptops were assigned to AEO-IT polling officials designated to these Electoral Constituencies as backup to tablets.

10 toll-free lines were used at the Call Center. 5 Digicel and 5 Vodafone. Two heavy duty printers were used at the Operation Center to provide hard copy printing services during election operation.

4.2 POLLING BOOTHS

A total of 77 Polling Booths were conveniently allocated throughout the six Electoral Constituencies for this By Elections, There were 46 polling booths for polling day, 10 special booths and 21 polling booths allocated for Pre Polling. The rationale was to provide ample opportunities for voters to cast their votes within the allocated timeframe, 8am to 3pm.

The allocation of polling stations depended on the size and number of registered voters for each village. Larger villages were allocated two polling stations and smaller villages were allocated one polling station. Majority of these polling stations were housed at church's halls.



Those who were registered to cast their votes during pre-polling process were the only eligible voters who could cast their votes on one day before the election day. These includes pension holder citizens who are 65 years and over, people with disabilities and those who will be travel overseas during the week of polling. It aim was to eliminate registered voters who were not able to participate to cast their vote during the election day due to their disabilities, older ages and travel before the election.

Special booths were set up at Tuanaimato Gym 1,Gym 2 for each Constituency, and one special booth was set up at our temporary Office at Bluebird Mall Salelologa, Mobile booths were operated at the National Hospitals, District Hospitals (Upolu/Savaii), Mapuifagalele, and Essential Services only on the election day.

4.3 POLLING OFFICIALS

The recruitment and selection of Polling Officials are appointed by the Electoral Commissioner as stipulated in Section 56 of the Electoral Act 2019.

Selection of Officials for the By-election focused on public servants that were recruited during the general election who were available at the time of the byelection.



4.4 TRAINING FOR POLLING OFFICIALS



Training programs commenced on the $16^{\text{th}} - 19^{\text{th}}$ November 2021.

These programs were divided into four (4) set of groups per role (PC, AEO-IT, AEO & EO) and were arranged two (2) sessions a day.

All in all, 320 officials were deployed for both pre-polling and polling day.



4.5 DEPLOYMENT

The deployment process was conducted at the Operation Centre. Officials working on Pre-polling were deployed on Wednesday, 24th November 2021. Transportation were arranged to pick and drop off officials, before and after polling.

Polling Officials deployment on Thursday, 25th November 2021 for polling day was scheduled according to their designated booths. Rural electoral constituencies were given the priority and early deployed whereas urban constituencies were put at last.



4.6 STATEMENT OF EXPENDITURE




The expenditure report below summarizes transactions and activities undertaken for the six (6) Electoral Constituencies contested in this By-election.

As depicted in the table and pie graph below, the highest expense falls on the polling officials; allowances, followed by the cost of Polling Booths venues including hirage of Multipurpose Gym and printing costs which includes printing of electoral rolls and ballot papers for the 6 electoral constituencies

4.7 NOMINATION OF CANDIDATES



At the close of nomination on Friday 5th November 2021, a total of 22 Candidate Nominations were accepted by the Commissioner to compete for the By-Election.

However, at the end of a Candidacy Challenge filed by one of the Candidates, the Constituency of Falealupo was ruled uncontested by the Court bringing the total of Candidates to contest for By-Elections to 21.

At the close of withdrawal of nomination on Friday 12th October 2021, a Candidate from the Constituency of Aleipata Itupa i Lalo withdrew his Candidacy leaving only 20 Candidates to contest the By-Elections.

4.8 PRE BY-ELECTION PETITIONS

By the closing date of application for Candidacy Challenges only one matter was lodged in Court by Fuiono Tenina Crichton against the nomination of Tuitogamanaia Dr. Peniamina Leavai ("Tuitogamanaia") citing that Tuitogamanaia did not render any religious monotaga for three consecutive years under the Tuitogamanaia's matai title at the Ekalesia Faalapotopotoga Kerisiano Samoa at Vaotupua Falealupo.

After the hearing of witnesses accounts from both sides, it was held by the Court that, Tuitogamanaia Dr. Peniamina Leavai did not render any religious monotaga under his title Tuitogamanaia therefore his Candidacy as approved by Commissioner is voided.

4.9 UNCONTESTED BY-ELECTION

The Constituency of Falealupo at the time of the nomination period had two Candidates accepted by the Commissioner. However, after the conclusion of the Candidacy Challenge, Falealupo Constituency was left with only one Candidate thereby, rendering the Falealupo Constituency as Uncontested.

4.10 PRE-POLLING DAY

Pre-Polling registration commenced for the registered voters of Sagaga 4, Safata 2 and Falealupo from the 1st - 12th November 2021. At the close of pre-polling registration, 14 new applications, all from the constituency of Falealupo were approved. This was before the court ruled the constituency of Falealupo uncontested.

A total of 1,011 registered voters from the six (6) constituencies, were eligible to pre-poll for By-Elections.

Pre-Polling took place on Wednesday 24th November 2021. All applicants were encouraged to use the opportunity to prepoll to avoid the large crowds on polling day. Polling booths were set up in different constituencies to cater for the registered pre-poll voters.

4.11 POLLING DAY

Polling Day was on Friday 26th November 2021. All Polling Booths were opened from 8.00am to 3.00pm.

Following the re-activation of special booths by the Electoral Act Amendment 2021, all voters from six Constituencies were eligible to cast their special votes from their constituencies of residence or use the special booths that were set up.

At the closing of poll, ballot boxes were escorted to Multipurpose Gym at Tuanaimato by the Police and Electoral Officers. Same goes with the special and mobile ballot boxes in Savaii, it was transported to the head quarter office at Tuanaimato, by Police Officers and officials to be counted together in the official count.

As usual Police guard was on duty guarding the ballot boxes until the official count was completed.

At the close of polling, preliminary results were relayed via WhatsApp. We noticed the rapid response by polling officials with their results coming in right after the preliminary counts were done at their respective polling booths.

Upon receipt, results were not only manually recorded on black boards within the Multipurpose Gym but were also posted on the office Facebook page – Office of the Electoral Commission – Samoa.



Relaying of Results

4.13 OFFICIAL COUNT.

The Official Count process started a day after polling, on Saturday 27th November 2021. The usual task was the sorting of special votes to corresponding Constituencies in the presence of scrutineers. This task commenced from 1pm to 6pm on Saturday.

The official count started on Monday 29th November where ballot boxes were opened in the presence of scrutineers, media representatives, observers and Police Officers.

The official count process started with the scrutinizing of rolls, verifying and counting of every votes until the Electoral Commissioner officially declares the official results. This process started at 9.00am and was completed at 6.00pm on the same day. After the scrutiny of rolls no dual votes were found.

Every ballot paper was verified to ensure that each contained an official booth mark. Votes were then sorted according to Candidates and were then counted. Counting Officers completed a result slip on which the results of total votes were reconciled with the number of ballot papers issued for each Polling Booth. Candidate scrutineers after verifying the results signed off on the result slips.



Distribution of Special Votes

Although there were candidates that did not send scrutineers, their absence did not invalidate the process. After the official count the result from the preliminary count remained the same despite a slight increase in votes as a result of special votes.


The official count results were advertised by way of a public notice and reported to the Head of State from which a Warrant of Election for the successful candidates was issued under proclamation. After the Official Results, four new Members of Parliament were from the FAST Party and two from the HRPP Party.



PERCENTAGE OF VOTES PER CANDIDATE







4.15 FEMALE CANDIDATES

The Constitutional Amendment Act passed in June 2013 which allowed a minimum 10% of the current 51 Seats for women representing the 51 Constituencies and according to our new Electoral Act 2019, were contested in Court. As a result two seats needed to satisfy the quota to make up for six women parliamentarians as per court decision.

The two (2) women candidates for this by-election were Lolomatauama Eseta Faalata Mataituli from Aana Alofi 2 and Faagasealii Sapoa Feagiai of Aleipata Itupa i Lalo. Unfortunately, none of the two made it through as Section 44 1A of the Constitution which requires 6 women MPs to be in Parliament is still in question.



5. POST-ELECTION PERIOD ACTIVITIES

5.1 BY-ELECTION PETITIONS

There were two (2) election petitions out of the six (6) By-Elections of November 2021. These two includes:

i) The matter between Leleimalefaga Neemia Fonotia v Maiava Fuimaono Tito Asafo of the Electoral Constituency for Falealili No. 2 when it was called on 7 February 2022 it was indicated by the lawyers of both parties their intention to have the matter withdrawn. The Court gave time for both lawyers to provide Notice of Withdrawal and Affidavits in support of Notice.

ii) In the matter of Fata Ryan Schuster v Maulolo Tavita Amosa of Sagaga No.2 Electoral Constituency, counsel for Fata Ryan Schuster appeared and informed Court that both parties have come to a mutual agreement to withdraw the matter. As such, matter was also adjourned for both parties to file and serve Notice of Withdrawal with Affidavits in Support.

In that regards, both are awaiting official withdrawn from the Courts of both matter when this report is compiled.

5.2 VOTER TURNOUT

Table 8 depicts a clear comparison in the total number of votes casted within the six (6) Electoral Constituencies in the General Election and By-Elections 2021 in proportion to the total registered voters.

In the General Election 2021, 28% of registered voters did not cast their votes. In comparison to the By-Elections that took place 7 months later, the total number of voters who did not cast their votes increased to 35%.




Table 9 outlines the number of registered voters (total roll), number of votes casted including informal and formal votes, and the proportion of votes casted to the electoral roll of every Constituency in the 2021 By-Elections.

Table 9 is sorted by Constituencies with the highest proportion of votes casted compared to total registered voters. All six (6) Constituencies had 60 - 68% of registered voters who casted their votes with Sagaga 4 holding the lowest proportion of 62%.

5.4 COMPARISON OF VOTES CAST INSIDE & OUTSIDE THE CONSTITUENCIES

Table 10 and Figure 5, compares the number of votes casted within the six (6) Constituencies and the number of votes casted outside of these Constituencies in the General Election and By-Elections 2021.

Figure 5, illustrates the decreases of votes casted within each Constituency during the By-Election as opposed to the General Election. The decrease in total of votes casted in the six Constituencies is 1064 (11%) votes. The massive decrease was triggered following the number of people who travelled overseas for Recognized Seasonal Employers (RSE).







Figure 6 below indicates the comparison of votes casted inside and outside of the six Constituencies in both the General Election and By-election 2021. The graph clearly shows that more voters voted inside and less outside of the Constituencies in the BE and vice versa during the GE 2021. As indicated by table 10, 16% reflects the number of voters residing outside of the six Constituencies and had to travel to the Constituency to cast their votes.

The graph below indicates that the age group 31-40 has the majority of registered voters who casted their votes compared to other age groups. In the 2021 General Election the male gender had the larger proportion of those who casted votes. In comparison with the By-Election that took place seven (7) months later, the female gender took over with the larger proportion of votes casted.




Figure 8: Votes Cast by Age & Gender
